Mr. Böll worked as a research assistant at the Technical University of Darmstadt, where he conducted research on the field of color perception of light sources.



Mr. Lam not only developed the technologies on energy efficiency testing for CFLs, but also provided technical support and training for relevant manufacturers, governmental

departments and public associations. He further developed the testing technologies on LED lighting, including energy efficiency, light distribution and photo-biological safety testing. He represented Intertek Hong Kong in acquiring the accreditations for lighting performance testing, such as HOKLAS, NVLAP (Energy Star), etc.

Presentation Outline

Over the past five years there has been strong demand for solid state lighting in South America and Middle East region. South American and Middle East lighting manufacturers and those considering export to these countries/regions should conduct market-specific product testing in compliance with the related regulations and requirements. Mr. Lam shall introduce the new standards and requirements updates of all lighting products, also the compliance challenges for the South American and Middle East markets focusing on the IEC and related national standards.
